The plans of correction for the statements of deficiency from the recent survey were submitted to the Wisconsin Department of Health Services, Division of Quality Assurance for review and approval. Many of the building issues that were cited were easy fixes such as caulking an area that is in the ceiling, moving an item that was in front of an electrical panel, marking the oxygen area to clearly indicate empty and full tanks. Improvements needed to be made by the Environmental Services department in the process of documenting fire drills and fire extinguisher checks. The facility also has to submit plans to the state for placement of a sprinkler head in a location behind the dryers. The sprinkler head was not part of the original plan when the facility opened. The health deficiencies cited have already been corrected. One was regarding a medication reduction for a resident and the other plan of correction involves providing education to the nursing staff regarding storage of medications. The great results of this year's survey are due to the wonderful staff of the Baldwin Care Center! I appreciate everything that the staff does for the residents.



The Baldwin Care Center campus would like to welcome the new staff in the Environmental Services Department. Kevin Brathol began working on May 17th as the Maintenance Technician. Kevin replaced LeRoy Dull who retired. Kevin had prior experience working for the Baldwin-Woodville school district. We welcome Warren Hanson to the role of Director of Environmental Services. Warren began his responsibilities on June 14th. Warren has prior experience as a Director of Environmental Services at another senior campus. Warren and Kevin are doing a great job. They make a great team.

The changes in the visiting policy seems to be going well. The expansion of the visiting hours is appreciated by everyone. I know residents and family members are enjoying being able to visit longer. The visiting guidance from the federal and state regulatory agencies has not changed. Facilities still need to have visitors complete a health questionnaire and have their temperature taken. Visitors must remain masked while in the hallway on their way to visit residents in their rooms. We are still unable to accommodate family coming in to eat with residents. Residents continue to enjoy being able to eat in the dining room with friends and attend group activities. The guidance still indicates that if an unvaccinated resident attends an activity, all residents must wear a mask. Residents who are not vaccinated still need to be seated six feet away while dining. As always, when any of this guidance changes, I will be sharing it with you.
